Personal Data that we process

Storm processes your personal data as a result of your current or past membership of the association. You have provided us with these personal data yourself. Below, you can find an overview of the personal data we process:

- First and last name
- Gender
- Date of birth
- Address
- Phone number
- E-mail address
- Data about your activity on our website
- Bank account number

Special and/or sensitive personal data we process

Storm does not save any special and/or sensitive personal data. These data are described as special and/or sensitive personal data under the Special Personal Data Act. Examples are race, religion and political preference.

With what objective and based on which principles we process personal data

By order of Storm, Congressus processes your personal data. Congressus has no power or control over the personal data and does not use these data for their own purposes. Storm remains responsible for the execution of the obligations that follow from the Personal Data Protection Act.

Storm processes your personal data via Congressus for the following objectives:

- To settle your payments (contribution or activities for which you subscribe)
- To send our weekly newsletter
- To be able to call or email you when necessary for the execution of our services

- To give you the opportunity to create an account
- Storm analyses your behavior on the website to be able to improve it.

Automated decision-making

Storm does not make decisions that may have (substantial) consequences for individuals based on automated processes. These are decisions made by computer programmes or systems, without the interference of a person (for example a board member of Storm).

How long we save your personal data

Storm does not save any of your personal data longer than needed to achieve the goals for which we have collected your data. Storm saves personal data in order to keep an overview of the current and past active members in the association, which means your data will be saved for an undetermined period of time. Sharing personal data with third parties

Storm does not sell your personal data to third parties and will only provide these when it is necessary for the execution of our agreement with you or to fulfill a legal obligation. We sign a processor agreement with all parties who process your personal data under our instructions. This way we can ensure an equal level of safety and confidentiality of your data. Storm always remains responsible for the processing of your data.

Cookies or similar techniques we use

Storm's website uses functional, analytical and tracking cookies. A cookie is a small text file that is saved in the browser of your computer, tablet or smartphone when the website is visited for the first time. The following cookies have been placed on the website:

1. Google Analytics
A Google Analytics cookies measures the traffic on the website
2. New Relic
A New Relic cookie is used to monitor the performance of the website. We can see the loading time of a webpage and keep track of possible flaws of the website.
3. Congressus cookies
Congressus cookies are functional cookies that, for example, can keep track of the frequency with which a member logs in on the website. These cookies ensure the functionality of the website.
4. Other cookies
On our website you find icons that are linked to the social networks Facebook and LinkedIn. These icons work through codes that come from Facebook and LinkedIn themselves. Through this code, cookies are placed. We cannot influence this. Read the

privacy statements of Facebook and LinkedIn (which can change regularly) to know what they do with the (personal) data that they gather through these cookies.

On your first visit to this website, we have informed you about our cookies and we have asked for your permission to place them. You can unregister for cookies and remove all the information that has been saved through cookies by changing the settings of your internet browser.

Viewing, correcting or removing personal data

You have the right to view, correct or remove your personal data. Furthermore, you have the right to revoke your authorization for the processing of your personal data or to object to the way Storm processes your personal data. You also have the right to data portability. This means you can submit a request for us to collect all the personal data we have from you in one file, so we can send it to you or to another organization. You can send a request to view, correct, remove or transfer your personal data or to withdraw your authorization or to object to the way we process your personal data to secretaris@stormutrecht.nl. To ensure the request is made by you, we ask you to send a copy of an identification document as well. Make your picture, MRZ (Machine Readable Zone), passport number and social security number unreadable. This is for the protection of your privacy. We will respond as soon as possible, but within four weeks. Storm also wants to notify you of the possibility of filing a complaint with the national monitor, the Dutch Data Protection Authority (*Autoriteit Persoonsgegevens*) when you do not feel satisfied with our examination of your request.

How we protect your personal data

Storm takes the protection of your personal data seriously and takes fitting measures to prevent the abuse, loss, unauthorized access, unwanted disclosure and unauthorized modifications of your personal data. Whenever you feel like your personal data are not protected properly or when there are signs of abuse, please contact us via secretaris@stormutrecht.nl.

Media footage
